* **Transfers are not possible mid-year/semester 2** for courses that only have one intake at start year; Master of Economics, Master of Applied Econometrics, Master of Actuarial Science or Master of Commerce (Actuarial Science). Applications to transfer will only be accepted for these courses for semester 1.

Students who are already admitted to the Master of Finance (MC-FINANCE) or Master of Finance (Enhanced) (MC-FINENH) can submit a request to transfer between these two courses. Students in any other MBS course who wish to transfer into the MC-FINANCE or MC-FINENH or the Master of Entrepreneurship **must submit an application**.
